To provide as much information in a timely manner, USA Shooting is releasing this Preliminary Notice to the Shotgun Athlete Selection Procedures for the 2025 Junior Pan American Games (Games). This document is being written as a complement, and not a substitute to the 2025 Junior Pan American Games Shotgun Athlete Selection Procedures. Additional communication will be released by USA Shooting once the Athlete Selection Procedures have been finalized.

#### **2025 Junior Pan American Games Overview**

The Junior Pan American Games are scheduled for August 9–25, 2025, in Paraguay. **All participants must be born in 2004 or later to be eligible to compete.**

USA Shooting is eligible to earn up to two (2) quotas per gender in both Trap and Skeet at the 2025 Junior Pan American Games. Quotas will be assigned to USA Shooting and will not be given to the athlete by name.

#### **Qualification Event:**

The 2025 Junior Pan American Games Selection Matches have been designated as USA Shooting Junior Division Selection Matches 2 & 3, and will take place in West Palm Beach Florida, January 22-February 2, 2025, and Hillsdale, Michigan, May 21-June 1, 2025.

USA Shooting Junior Division Selection Matches 2 & 3 are open to all active USA Shooting members that are born in 2004 or later.

Available quotas for the Games will be awarded to athletes by order of placement finish in each event (Trap and Skeet) at the conclusion of Selection Matches 2 & 3.

The selection of the top placing athletes will be based on:



1. Combined Qualification score from Selection Matches 2 & 3. (out of 500 targets, 250 per competition)
2. In the case of a tie, a miss and out will determine ranking order.

3. Should an athlete decline or become ineligible, and replacements are still permitted by the Pan American Sport Confederation, the next highest placing athlete in the same event at Selection Matches 2 & 3 will be nominated to the Team.
